FOR MANY STUDENTS, THIS WILL BE THEIR FIRST TIME ATTENDING A SCHOOL OF ANY KIND AS THERE ARE CURRENTLY NO OTHER TUITION-FREE SCHOOLS IN THE REGION.

OPENED THE PLAYING FOR CHANGE MUSIC PROGRAM IN A TEACHING CENTER IN AFRICA. CLASSES ARE OFFERED IN FLUTE, HARMONIUM, GUITAR AND DRUMS.
